Whose underground lines are you digging near?

Is the safety of your employees important to you? If you answer yes to this question, then you must CALL before you Dig, it is the safest thing to do.

Dial 8-1-1 or 1-800-242-1776 not less than three business days nor more than ten business days prior to the start of your excavation work. One simple phone call can help keep your employees safe on the job site.

Pennsylvania One Call System's facility owner members will receive the information about your job and mark the location of their underground lines at the site. Knowing the location of the underground lines at your job site can give you a sense of security that you are taking one of the steps necessary to keep your employees, your customers, and anyone in the vicinity of the job site safe.

Don't just call Pennsylvania One Call System because you are required to do so by Law, do it because it is the right thing to do for everyone involved. Remember to mark your proposed excavation area in white.

Dial 8-1-1 Before you Dig!

On the job site, would you operate a piece of machinery you knew to be faulty, that could malfunction at any moment? Would you let your employee use equipment with frayed wires? We are sure the answer is no, so why would you let them dig at a worksite where the underground lines are not marked? Make safety a priority and look for the following colors at the jobsite before you dig. Please follow trench safety rules.

White	Proposed excavation
Pink	Temporary survey markings
Red	Electric power lines, cables, conduits and lighting cables
Yellow	Gas, oil, steam, petroleum or gaseous materials
Orange	Communication, alarm or signal lines, cables or conduits and traffic loops
Blue	Potable water
Purple	Reclaimed water, irrigation and slurry lines
Green	Sewer and drain lines


