

## INSTRUCTIONS TO VISITORS

Because of the hazards and risks associated with any construction site, we require every visitor to the Site(s) to be alert for their own safety and to sign a written Waiver and Release absolving PDM CONSTRUCTORS, INC. / DURAPODS, LLC, the owner, landlord and others of any and all responsibility in connection with all risks encountered at the Site(s).

While on the Premises, please be on guard constantly and follow good safety practices including, but not limited to, the following:

1. Where required, hard hats must be worn by all visitors at all times.
2. All visitors should wear appropriate closed-toe footwear while in the manufacturing facility.
3. All visitors are to be escorted at all times while on the Project Site.
4. BE ALERT for changing conditions and ongoing construction activities while walking on the Project Site. LOOK and LISTEN before you move from one position to another.
5. Be aware of uneven walking surfaces and extreme care should be taken with each step.
6. No firearms, drugs or alcoholic beverages are permitted on the site. If alcoholic beverages are made available during your visit, only individuals of legal age to consume alcoholic beverages are permitted to consume them in accordance with state laws. If necessary, arrangements should be made for transportation after your visit if alcoholic beverages are consumed.
7. All warning signs and barricades must be obeyed.
8. Do not stray from the approved path for ingress and egress.
9. Do not enter areas with inadequate lighting.
10. Be aware of and stay clear of any overhead hazards.
11. Smoking is only permitted in designated areas.
12. Do not touch materials of any kind without written authorization from PDM CONSTRUCTORS, INC. / DURAPODS, LLC.
13. Do not lean on or reach beyond any handrails or barricades.
14. Report any hazards to a PDM CONSTRUCTORS, INC. / DURAPODS, LLC\_ representative prior to leaving the site.
15. No written correspondence regarding any hazards observed on the site shall be written or forwarded after leaving the site unless previously agreed upon at the site.
